

- Nothing in this Agreement shall be construed to be an adminusion of liability or wrongdoing by any party;
- 6. It is understood and agreed that this is the entire and only agreement between the parties and that it will be filed in open Court;
- It is understood and agreed by the parties that the 7. agreement of each of them to this Stipulation of Settlement and Release is not subject to any condition, and that the consideration regited herein is the sole consideration for the parties' Agreement to this Stipulation.
